This is a funeral where family and friends have a ceremony, event or service for the deceased person at the same time as they attend their burial or cremation.	
Taking care of all necessary legal and administrative arrangements.	£816.00
Collecting and transporting the deceased person from the place of death (normally within 15 miles of the funeral director's premises) into the funeral director's care.	£315.00

Providing a suitable coffin – this will be made from MDF with a paper wood effect foil finish.	£229.00

At a date and time you agree with the funeral director, taking the deceased person direct to the agreed cemetery or crematorium (normally within 20 miles of the funeral director's premises) in a hearse or other appropriate vehicle.	£320.00

UNATTENDED FUNERAL	
This is a funeral where family and friends may choose to have a ceremony, event or service for the deceased person, but they do not attend the burial or cremation itself.

FEES YOU MUST PAY	
For an Attended or Unattended burial funeral, the burial fee . ¹ In this local area, the typical cost of the burial fee for local residents is:	£900.00 - £1299.80
For a new grave, you will also need to pay for the plot; for an existing grave with a memorial in place, you may need to pay a removal/replacement fee. In addition, the cemetery may charge a number of other fees.	
For an Attended cremation funeral, the cremation fee . ² In this local area, the typical cost of a cremation for local residents is:	£660.00 - £950.00

² In England, Wales and Northern Ireland, you will usually need to pay doctors' fees as well. This is the charge for two doctors to sign the Medical Certificates for Cremation.

For an Unattended Funeral service, the following terms apply: -

- Full Payment is required at the point of arrangement.
- No discount or early settlement offer.

For an Attended Funeral Service, and all other funeral related services, excluding memorialisation, the following terms apply: -

- All disbursement (3rd Party) charges and 15% of our professional service fees, must be paid in full and in advance of the funeral being conducted. We reserve the right to postpone the funeral until such charges are paid in full. Payment must be made at least 48 hours in advance of the funeral date.
- We reserve the right to request full payment of the written estimate, regardless of the type of funeral selected, under certain circumstances.
- Full Payment of goods and/or services provided, are due within 28 days of us providing you with a valid invoice.
- We may charge interest on the overdue amount at the rate of 10% a year above the base lending rate of the Bank of England from time to time. This interest shall accrue daily from the due date until the date of actual payment of the overdue amount, whether before or after judgment.
